AGREEMENT TERMS

1. PAYMENT AND BOOKING	Deposit required to secure vessel. Remaining balance due 48 hours before departure.
2. BOARDING AND DEPARTURE	Arrive 15-20 minutes early for check-in and safety briefing.
3. PASSENGER LIMITS	Must comply with U.S. Coast Guard regulations.
4. SAFETY RULES AND CONDUCT	Follow captain instructions at all times. Unsafe behavior may end charter with no refund. Swimming only with captain approval. Children under 13 must wear life jackets.
5. WEATHER POLICY	Only the captain may cancel or delay. Unsafe conditions include lightning, high winds, fog, or hazardous waves. Weather cancellations receive a reschedule or credit.
6. CANCELLATIONS AND REFUNDS	Deposits are non-refundable. Cancellation within 48 hours requires full payment. Captain cancellations receive a reschedule or credit. No-shows forfeit all payments.
7. ALCOHOL AND SUBSTANCE POLICY	Alcohol allowed in moderation. Illegal substances prohibited. Smoking only in approved areas. Glass is discouraged.
8. DAMAGE LIABILITY	Client is responsible for damage, excessive mess, or lost items.
9. FOOD AND OUTSIDE ITEMS	Food and catering allowed. No open flames. Coolers must not block walkways. Trash must go in bins.
10. INDEMNIFICATION	Client indemnifies LDG Charters for the actions of themselves or their guests.
11. HARBOR RULES	All guests must comply with harbor and U.S. Coast Guard regulations.
12. FINAL TERMS	This agreement is governed by Illinois law. Any modification must be in writing.
